**October 24, 2019 – Understanding the Grief Process
9-12:15 p.m.**

This workshop is designed for professionals who are interested in exploring current perspectives on the grief process. It will focus on new insights and attitudes regarding models of grief that have emerged in the field of death and dying. Participants will be exposed to these new perspectives in an interactive, small group environment. This course is designed as a basic introduction to a widening field of grief and bereavement. Upon completion of this training, participants will be able to identify how the experience of grief is viewed in the context of models and patterns such as: dual processing, attachment theory, continuing bonds and narrative styles of grief work. Cultural and gender of styles of grieving will be introduced and explored.

**March 26, 2020- Addiction Aftermath
9-12:15 p.m.**

The opioid epidemic has brought the pain and struggle of addiction to the forefront. While the incidence of death from opioids is rising and is certainly more visible now than ever before, death from all types of addiction is devastating to families of loved ones who die. How do we help addiction survivors cope with this devastating loss? We will explore death from addiction from the perspective of the survivor. What challenges do they face internally as they adjust to this loss? How can we help them adjust to and process their response to loss, which is often isolating and confusing?

**On April 23, 2020- Suicide Aftermath
9-12:15 p.m.**

There are many illnesses and diseases such as Alzheimer's, Dementia and Stroke, to name a few, that often leave individuals and families experiencing what is called "ambiguous loss". This training will focus on how to help clients manage sudden changes and process the emotional aftermath following loss of independence, changes in caregiver status, personality shifts and decline of physical bodily functions.
