A YEAR IN REVIEW

Looking ahead towards 2020 brought with it much anticipation and excitement for those invested in The Center for Loss and Bereavement's valuable mission. It marked the twenty-year milestone of establishing trust, dedication, and groundwork in our field. Our leadership team approached this anniversary with great hopes and energy fueled by a strategic planning process focused on strengthening our programming and partnerships, and on building more capacity for our future. We planned events that would bring our stakeholders and community together in honoring the positive impact our mission made in twenty years of foundational work. We recruited additional staff and board members in responding to increased demand for our services and embarked on regional partnerships for national research on better serving underrepresented populations in our grief work. The momentum was set to build on the immense progress made in our first twenty years by deepening our resolve for the next twenty.

This momentum was disrupted when the Covid-19 pandemic took hold of the world, bringing sobering public health concerns of devastating trauma and grief, along with intensifying strife, to the masses. The board and staff of The Center for Loss and Bereavement banded together to effectively and carefully meet these challenges, creatively adapting our responses to the growing needs of our grieving clients and community. Consistently pivoting throughout this last year, our team shifted gears but not focus on our vision. We used new strategies to engage with our partners and reach those most impacted by the isolation and devastation of grief in this complicated time.

The generosity of those who strengthened our capacity with guidance, resources, and contributions of support ensured that the Center would remain a source of light and hope through what has become one of the most grief-laden, overwhelming periods in lived history. Our services continue on the path blazed twenty years ago, but have now grown with added compassion and insight into just how massively grief can disrupt both lives and communities, and also how integral the support of others is to our ability to provide our specialized services. The pages ahead demonstrate the many ways we were able to bring connection, knowledge, and solace to help others find healing in the wake of profound loss over the years, and in this past year of remarkable grief. We hope you'll take interest in learning more about our work, and find our mission worthy of further support as we restore better health and community connection to others grieving through the long road of recovery we now face, together.

SERVICES

SPECIALIZED GROUP SUPPORT

We offer special interest support groups for bereaved adults of all ages. Each year we bring together individuals with shared loss in a closed group format to offer comfort, understanding, and perspective in finding strength while living with grief. Some of our frequently run groups:

- Adult Loss of a Parent
- Loss of Spouse or Partner
- Support for Suicide Loss
- Young Adult Grief Support
- Loss of a Child
- Loss due to Addiction/Substance Abuse



Counseling is available at any time for those who wish to have individual, couple, or family therapy from one of our specialized, credentialed counselors. Our therapists have extensive training and experience supporting clients dealing with anticipatory or permanent losses of life, health status, or ability. We approach each person or family with personalized care, offering varying support levels, ranging from short-term or as-needed guidance and support to ongoing intensive therapy for those dealing with the most complicated, traumatic loss experiences. Our counselors are compassionate professionals and maintain excellence in training and integrity.



TRAINING AND PRESENTATIONS

The Center's resources are also made available to better strengthen the community by increasing awareness about grief and loss. In-service programs and training workshops have been given to countless groups, including schools, colleges, retirement communities, local businesses, and other professional/volunteer groups. Our staff regularly receive specialized training in grief topics and a wide breadth of mental health core competencies to ensure we are practicing and teaching from current knowledge and trends in our field of expertise. We are an approved Continuing Education provider through the Pennsylvania State Board of Licensed Clinical Social Workers, Marriage and Family Therapists, and Professional Counselors. We also host presentations for youth and adult audiences.

CAMP MILLIE

Camp Millie is a summer bereavement camp offered to elementary and middle school-aged children who have experienced an immediate family member's death.

Launched in 2005, our summer bereavement camp strives to bring peer support, emotional expression, and coping skills, along with laughter and joy, into the lives of children who experience family grief. Children are invited into an environment of safety and hope. At Camp Millie, children's days are filled with summertime adventures, friendship, and support, along with activities that encourage the exploration of grief stories, reactions, supports, and memories.

CUSTOMIZED CONSULTATIONS

The Center for Loss and Bereavement's professional staff are available to consult with schools or community organizations for any specific topic or need that presents outside the scope of our other education or therapeutic services.

We can offer guidance and support for your leadership in structuring helpful responses to matters of grief, death, dying, or other complicating circumstances of loss-related

NELLO'S CORNER - PEER GROUP SUPPORT FOR YOUTH & CAREGIVERS

Nello's Corner is a special program that offers peer group support for children and their caregivers after experiencing an immediate family member's death. This program is offered at no charge to participants due to many donors' generosity, particularly the Nello Memorial Committee. In response to the loss of Nello Nattchione IV, the Nattchione family has added a great deal of financial support to this program to ensure that other families like theirs have access to quality care and the comfort of others during times of devastating family loss. Children, ages 4 through high-school, meet twice a month in the evenings, sharing activities and discussion while finding strength in the company of other children whose lives have been touched by death. The volunteers and staff at Nello's Corner provide a trusted, hopeful space where children can grieve and reconfigure what living means for them. Peer grief support groups are also facilitated off-site to schools and other organizations when requested.






INCOME-EXPENSE 2014-2020









PROGRAM PARTICIPANTS

The Center for Loss and Bereavement's most established areas of direct on-site service, counseling and support groups have relatively stable and predictable growth rates year-to-year. Despite the pandemic, we will take a broader and more profound look at our extended reach in the community. Through dedicated strategic planning efforts, in collaboration with other resources, we hope to determine the extent of grieving children and families whose needs are underserved due to access, equity, or other significant challenges in life. Our goal is to reinforce fundamental connections within our region to identify and provide added support to these vulnerable individuals. Additionally, in bringing our expertise to more organizations and resources in our community, we are positioned to offer specialized guidance to others working with this unmet population of grievers through our education and awareness efforts. In support of this overarching goal, we are taking strides to increase partnerships with individuals, businesses, and foundations that have the means and commitment to inspire resilience, hope, and positive growth.
