## SPECIALIZED GROUP SUPPORT

We offer special interest support groups for bereaved adults of all ages. Each year we bring together individuals with shared loss in a closed group format to offer comfort, understanding, and perspective in finding strength while living with grief. Some of our frequently run groups:

### COUNSELING

Counseling is available at any time for those who wish to have individual, couple, or family therapy from one of our specialized, credentialed counselors. Our therapists have extensive training and experience supporting clients dealing with anticipatory or permanent losses of life, health status, or ability. We approach each person or family with personalized care. We offer varying support levels from short-term or as-needed guidance and support to ongoing intensive therapy for those dealing with the most complicated, traumatic loss experiences. Our counselors are compassionate professionals and maintain excellence in training and integrity.

## TRAINING AND PRESENTATIONS

The Center's resources are also available to strengthen the community by increasing awareness about grief and loss. We have presented In-service programs and training workshops to countless groups, including schools, colleges, retirement communities, local businesses, and other professional/volunteer groups. Our staff regularly receive specialized training in grief topics and a wide breadth of mental health core competencies to ensure we practice and teach from current knowledge and trends in our field of expertise. We are an approved Continuing Education provider through the Pennsylvania State Board of Licensed Clinical Social Workers, Marriage and Family Therapists, and Professional Counselors. We also host presentations for youth and adult audiences in the general public.



## CUSTOMIZED CONSULTATIONS



The Center for Loss and Bereavement's professional staff are available to consult with schools or community organizations for any specific topic or need that presents outside the scope of our other education or therapeutic services. We can offer guidance and support for your leadership in structuring helpful responses to matters of grief, death, dying, or other complicating circumstances of loss-related concern.

## NELLO'S CORNER

Nello's Corner is a special program that offers peer group support for children and their caregivers after experiencing an immediate family member's death. This program is offered at no charge to participants due to many donors' generosity, particularly the Nello Memorial Committee. In response to the loss of Nello Nattchione IV, the Nattchione family has added a great deal of financial support to this program to ensure that other families like theirs have access to quality care and the comfort of others during times of devastating family loss. Children, ages 4 through high school, meet twice a month in the evenings. sharing activities and discussion while finding strength in the company of other children whose lives have been touched by death. The volunteers and staff at Nello's Corner provide a trusted, hopeful space where children can grieve and reconfigure what living means for them. Peer grief support groups are also facilitated off-site to schools and other organizations when requested.



## CAMP MILLIE

Camp Millie is a summer bereavement camp offered to elementary and middle school-aged children who have experienced an immediate family member's death. Launched in 2005, our summer bereavement camp strives to bring peer support, emotional expression, and coping skills, along with laughter and joy, into the lives of children who experience family grief. Children are invited into an environment of safety and hope. At Camp Millie, children's days are filled with summertime adventures, friendship, and support, along with activities that encourage the exploration of grief stories, reactions, supports, and memories.



## SCHOOL PROGRAMS

Being impacted by grief can cause an array of emotional and physical challenges and changes that naturally overflows into the school environment. When students and families have support the weight of these challenges can be lessened. We know that connecting and supporting your students is a top priority. As your local grief support, the Center for Loss and Bereavement hopes to partner with you to help meet your students' needs.






### **INCOME-EXPENSE 2014-2021**



Our fiscal year runs from July 1, 2020 to June 30, 2021. Below are the highlights from the past year.



#### **FUNDING BREAKDOWN**





## 2021 HIGHLIGHTS

### Strides of Hope

In November, hundreds of walkers and runners participated in the Strides of Hope 5K. We surpassed our fundraising goal and raised over \$37,000, bringing a great deal of warmth and inspiration to those involved in this special event! It reminds us that those who face profound loss never have to walk their trail alone.





## Fields of Hope

We hosted the very first Field of Hope Sunflower event. Hundreds of people embraced nature's beauty at the Smith Farm. Fields of Hope was joyful, inspiring, and fun. It allowed individuals to find connection and light while reflecting on those lost. We raised over \$33,000 to support the Center.





### Camp Millie

In June of 2021, we again hosted our summer bereavement day camp offered to children ages 6 to 12. At Camp Millie, 32 youth grieving the death of an immediate family member attended four days of group activities, mitigated safely for inperson gatherings. We kept our numbers limited to reduce the risk of COVID transmission, allowing social distancing. We also separately held our first mini-grief support camp for teens later in the summer. These two sessions were held onsite at our Center, offering a group for eight teens to connect, express their grief, and share in coping strategies. Our traditional camp for younger children and our teen extension camp were received positively as an opportunity for grieving youth to be with one another in the same physical space following a year of online groups.

#### Judi's House

The Center is a part of the Greater Philadelphia Grief Collaborative. Our Center recently completed the two-year Childhood Bereavement Changemaker (CBC) research project offered through Judi's House/JAG Institute, in conjunction with the New York Life Foundation. Participating in this research has provided us with the data and insights needed to better reach underserved and special needs in our grieving community while strengthening our partnerships across the region. We are grateful for these enriching opportunities that ensure we have quality programs and exceptionally trained staff.










## Community Butreach and Center Connections




#### **COUNSELING SESSION TOTALS**
